From the Manager's Desk...

Cumberland Township Municipal Building Project Update

As we embrace the winter season, Cumberland Township is diligently working on a crucial project to enhance community safety and infrastructure. The Cumberland Township Municipal Building, originally constructed in 1979, has seen various additions and studies over the years. The recent focus is on a comprehensive renovation, spurred by considerations ranging from security enhancements to adapting to the challenges the Township faces. The Building Committee has thoroughly evaluated potential partners and assessed multiple options. The recommendation is to proceed with the renovation of the current building, including two small additions.

Project Highlights and Funding Overview

The project's scope extends beyond the building itself, encompassing updates to the parking lot, outbuildings, and the incorporation of security measures, totaling an estimated \$3,975,212.00. Securing funding for such a significant endeavor is no small feat. Governor Wolf's authorization of \$1,300,000.00 through the Redevelopment Assistance Capital Program (RACP) serves as a crucial cornerstone. Additional funding applications, such as a \$100,000.00 Local Share Account (LSA) grant for security improvements, and an additional RACP application for \$700,000.00, are currently in progress. Lastly over \$500,000.00 has been saved towards the project and a loan rounds out the financial plan.

Vision for the Future

The primary focus of the renovation project centers on bringing Cumberland Township's Police Department to contemporary standards, with a 75% expansion of their facilities. This includes updated office spaces, interview rooms, a secure evidence room, locker rooms, and ADA-compliant accessibility for all residents. The renovated building will also feature a modernized public meeting room, enabling various township and community gatherings, during or after township hours. The secure entrance and additional safety measures will ensure the well-being of both staff and the community. As we embark on this vital journey, Cumberland Township remains committed to transparency and community involvement, keeping residents informed every step of the way. Together, we build a safer and more resilient future for our community.

Winter driving requires extra caution due to icy and slippery conditions. Here are some essential safety tips to ensure a safe journey during the colder months...



First and foremost, slow down and maintain a safe following distance to allow for increased stopping time on icy roads.



Ensure your vehicle is winter-ready by checking tire tread, brakes, and fluid levels regularly.



Keep your headlights on to improve visibility in low-light conditions.



Always clear all snow and ice from your windows, mirrors, and lights before setting out.



Equip your vehicle with winter tires for better traction.

Winter Weather Guidelines



Need to get rid of a Christmas Tree?

You can drop off trees at the posted area located at the municipal building starting 12/26-1/15.



What is a Snow Emergency?

§ 21-201 Declaration of Snow and Ice Emergency. [Ord. 2/14/2006]

In order to facilitate the movement of traffic and to combat the hazards of snow and ice on the snow emergency routes named in § 21-203 of this Part, the Chairman of the Board of Supervisors or his designee may declare a snow and ice emergency (designated in the Part as a "snow emergency"). Information on the existence of a snow emergency shall be given by the Township through radio, newspaper or other available media, and information on the termination of the emergency may be given by use of the same media.

What does that mean for me?

§ 21-202 Parking Prohibited, Driving Motor Vehicles Restricted on Snow Emergency Routes During Emergency.[Ord. 2/14/2006]

1. After any snow emergency is declared, it shall be unlawful, at any time during the continuance of the emergency, for any person:
 - A. To park a motor vehicle or to allow that vehicle to remain parked on any Township road or any Township right-of-way in such a manner as to impede or obstruct the snow and ice removal efforts of the Township of Cumberland or to create a hazardous condition.
 - B. To drive any motor vehicle on the snow emergency route as designated in § 21-203 of the Part, unless the vehicle is equipped with snow tires or chains.

§ 21-204 Towing.[Ord. 2/14/2006]

Any vehicle parked in violation of this Part shall be subject to towing at the owner's expense. The Chief of Police or those operating under his direction shall attempt to contact the owner of the vehicle to notify the owner of the impending towing. If within one hour of attempted notification the vehicle shall be deemed as a hazardous condition to the snow and ice removal efforts of the Township of Cumberland and be subject to towing.

What if there is damage to my mailbox during plowing?

Cumberland Township will only repair a mailbox if our plow physically strikes the mailbox. We will not repair a mailbox if the damage is caused by the snow throw (cast) from the plow. Residents with mailboxes that are road or street side are encouraged to follow United States Postal Service guidelines regarding the erection of the posts for sturdiness and the height of the bottom of the mailbox.

It is unfortunate when plowing snow damages a privately owned mailbox. The Township does not prohibit a property owner from placing their mailbox within the limits of the legal right-of-way. Mailboxes, however, are placed by the property owner within the Township right-of-way and remain at the risk of the mailbox owner.

Therefore, the Township is not liable for damages to mailboxes, fencing, shrubbery, trees, or any other privately owned appurtenances caused by snow removal activities.



While there are similarities in their functions, the key differences lie in their size, urbanization, and the range of services they provide to their residents.

Sewer Rate Increase

The Cumberland Township Authority is increasing sewer rates effective January 1, 2024. The new rate per quarter will be \$143.00 per equivalent dwelling unit (EDU) which includes capital improvement funding. The five-dollar increase (3.9%) will appear on the January billing statements. The last sewer increase was ten years ago.

The Authority has experienced inflationary increases with all costs of operations for the two wastewater treatment plants and the eight pumping stations. Additionally, laboratory and chemical costs have increased along with additional testing requirements from the Pa. Dept. of Environmental Resources. The two treatment plants are nearing 20 years of age so the need for upgrades is ongoing. Capital projects were initiated in 2023 that will continue in 2024 and 2025. Additionally, a full-time operations employee will be hired in 2024 to assist the current operations staff of three full-time and two part time employees."

Residential growth continues to expand requiring additional personnel and pro-active preventative maintenance seven days a week.

The Cumberland Township Authority appreciates the cooperation we receive from our citizens and customers. Online payments can be made through the Authority's customer portal found on the Cumberland Township website www.cumberlandtownship.com. Once registered, customers can sign up for e-billing, make an ACH payment free of charge or a credit card payment (fees apply). Automatic payments are also available by completing the Sewer Payment Automatic Withdrawal Form found under Permit Forms, Applications and Documents on the Cumberland Township website.

The Affordable Connectivity Program

What is it?

The Affordable Connectivity Program is an FCC benefit program that helps ensure that households can afford the broadband they need for work, school, healthcare and more.

The benefit provides a discount of up to \$30 per month toward internet service for eligible households and up to \$75 per month for households on qualifying Tribal lands.

Eligible households can also receive a one-time discount of up to \$100 to purchase a laptop, desktop computer, or tablet from participating providers if they contribute more than \$10 and less than \$50 toward the purchase price.

The Affordable Connectivity Program is limited to one monthly service discount and one device discount per household.

Who Is Eligible?

A household is eligible for the Affordable Connectivity Program if the household income is at or below 200% of the [Federal Poverty Guidelines](#), or if a member of the household meets at least one of the criteria below:

- Received a Federal Pell Grant during the current award year;
- Meets the eligibility criteria for a participating provider's existing low-income internet program;
- Participates in one of these assistance programs:
 - Free and Reduced-Price School Lunch Program or School Breakfast Program, including at U.S. Department of Agriculture (USDA) Community Eligibility Provision schools.
 - SNAP
 - Medicaid
 - Your Medicaid eligibility may be up for renewal.
 - Federal Housing Assistance, including:
 - Housing Choice Voucher (HCV) Program (Section 8 Vouchers)
 - Project-Based Rental Assistance (PBRA)/Section 202/ Section 811
 - Public Housing
 - Affordable Housing Programs for American Indians, Alaska Natives or Native Hawaiians
 - Supplemental Security Income (SSI)
 - WIC
 - Veterans Pension or Survivor Benefits
 - or [Lifeline](#).

Let's Talk Storm Water!

How to Spot an Illicit Discharge

What's an "illicit discharge!?"

An illicit discharge is any discharge to a Municipal Separate Storm Sewer System (MS4) that is not composed entirely of stormwater or uncontaminated groundwater.

What are the most likely culprits?

- Sanitary sewer wastewater
- Effluent from septic tanks
- Car wash wastewater
- Improper oil/radiator flushing disposal
- Illegal or improper dumping
- Laundry wastewater/gray water
- Spills from roadway accidents
- Improper disposal of auto and household toxics
- Construction runoff
- Paint
- Pet waste
- Yard debris in street or drainage system
- Litter
- Cooking grease

Why should I care?

Residents should be vigilant and concerned about illicit discharges into the MS4 because these discharges have direct and detrimental effects on our local environment and water quality. Illicit discharges can contaminate our waterways, posing serious threats to aquatic ecosystems and public health. By caring about and actively preventing illicit discharges, residents contribute to the preservation of clean water resources, ensuring the well-being of both the environment and the community. Taking responsibility for what enters the MS4 is vital in maintaining a sustainable and healthy living environment for current and future generations. Regular awareness and collective action from residents are essential to safeguarding our water quality and promoting a thriving community.

How can I help?

Residents can play a crucial role in identifying illicit discharges from MS4 systems by being vigilant and observant. One indicator of illicit discharges is the presence of unusual colors, odors, or floating debris in stormwater runoff. Residents should be alert to any discharge that appears different from normal rainwater. Additionally, spotting the release of pollutants such as oil, chemicals, or sediment into storm drains is a clear sign of illicit discharges. Unusual foaming or the presence of unnatural substances in water bodies connected to stormwater systems can also be red flags.

Residents are encouraged to report any suspicious observations to the municipality, providing details such as location, time, and a description of the discharge. By actively participating in monitoring efforts, residents contribute to the protection of water quality and the overall health of their communities!

Only by working together can we protect our water supply!
